#### BYLAW NO. 1802.03

# A BYLAW TO AMEND THE REGIONAL DISTRICT OF NANAIMO RESIDENTIAL CURBSIDE COLLECTION OF GARBAGE, FOOD WASTE AND RECYCLABLES REGULATION AND CHARGES BYLAW

WHEREAS pursuant to "Recycling and Compulsory Collection Local Service Establishment Bylaw No. 793, 1989", the Regional District of Nanaimo is authorized to provide a service for the collection of Garbage, Recyclables and Food Waste;

AND WHEREAS the Board of Directors of the Regional District of Nanaimo has determined that a Regional Collection Service should be established and provided to certain areas and classes of land within the District;

NOW THEREFORE the Board of the Regional District of Nanaimo, in open meeting assembled, enacts as follows:

#### 1. CITATION

This bylaw may be cited for all purposes as the "Residential Curbside Collection of Garbage, Food Waste and Recyclables Regulation and Charges Amendment Bylaw No. 1802.03, 2024".

### 2. **AMENDMENT**

"Residential Curbside Collection of Garbage, Food Waste and Recyclables Regulation and Charges Bylaw No. 1802, 2020" is amended as follows:
