BYLAW NO. 1148

A BYLAW TO ESTABLISH THE REGIONAL DISTRICT OF NANAIMO ARROWSMITH BENSON-CRANBERRY BRIGHT OFFICIAL COMMUNITY PLAN

WHEREAS:

- A. Under section 883 of the *Municipal Act* the Board may adopt a community plan by bylaw.
- B. The Board of the Regional District has:
 - a. examined the plan in conjunction with its most recent capital expenditure program under section 329 of the *Municipal Act* and the Waste Management Plan and is assured of consistency between them; and
 - b. referred the plan to the Provincial Agricultural Land Commission, City of Nanaimo, Alberni-Clayoquot Regional District, and Cowichan Valley Regional District for comment; and the Board has received those comments.
- C. A Public Hearing has been held on the plan on the 29th day of April, 1999, being not less than 20 days after the plan has been referred to the Provincial Agricultural Land Commission, City of Nanaimo, Alberni-Clayoquot Regional District, and Cowichan Valley Regional District.

NOW, THEREFORE, the Board of the Regional District of Nanaimo in open meeting assembled HEREBY ENACTS AS FOLLOWS

1. Title

This Bylaw may be cited as "Regional District of Nanaimo Arrowsmith Benson-Cranberry Bright Official Community Plan Bylaw No. 1148, 1999".

2. Application

This Bylaw is applicable to Electoral Area 'C' of the Regional District of Nanaimo as shown outlined on Map No. 1, Sheet 1 of 3 of Schedule 'A' of this Bylaw.

3. Community Plan

The community plan is comprised of Schedule 'A' and Map No. 1 - Sheets 1 to 3; Map No. 2 - Sheets 1 to 3; Map No. 3 - Sheet 1 of 1; Map No. 4 - Sheet 1 of 1; Map No. 5 - Sheets 1 to 3; Map No. 6 - Sheets 1 to 3; and Map No. 7 - Sheets 1 to 5; which are attached to and form an integral part of the Bylaw.

4. Repeal

"Regional District of Nanaimo Cranberry, Bright Official Community Plan Amendment Bylaw No. 737, 1987, is repealed.
