REPORTS

Parks Update Report - January to March 2019

R. Lussier reviewed the Errington Community Park detailed design and costing of the playground. It is anticipated that this work be completed by September 2019. The Operator Agreement is on hold until the infrastructure report for the park is completed.

A. Dunn discussed the potential of volunteers creating a pump track at Meadowood Community Park. It was suggested that community representatives appear as a delegation at the Electoral Area F Parks and Open Space Advisory Committee to present their ideas for the park. The Committee would consider a recommendation for the proposed project following the presentation from the delegation.

Chair Salter discussed motorbike use on the Arrowsmith community trails. The concern is that this unauthorized use of the local trail system is not safe for all users and is damaging trail surfaces. Parks staff will assess the trail conditions and current signage provided.

Chair Salter advised the Parks and Open Space Advisory Committee that she opted out of the Community Parks Development Cost Charge Study for Electoral Area F.

It was moved and seconded that the Parks Update Report – January to March 2019 be received for information.

R. Lussier reviewed the planning worksheet draft for project planning from 2020-2024.

K. Smith discussed the importance of creating trails that are usable by people who have physical challenges.
