

Pursuant to Sections 464, 465 and 466 of the *Local Government Act* the Regional District of Nanaimo (RDN) advises of a Public Hearing regarding a zoning amendment for "Regional District of Nanaimo Electoral Area 'F' Zoning and Subdivision Amendment Bylaw No. 1285.36, 2020".


In consideration of current restrictions on in-person gatherings due to the COVID-19 pandemic, this Public Hearing is convened by electronic means as authorized by Ministerial Order No. M192, "Local Government Meetings and Bylaw Process (COVID-19) Order No. 3".

### **PURPOSE OF THE BYLAW**

The application proposes to amend "Regional District of Nanaimo Electoral Area 'F' Zoning and Subdivision Bylaw No. 1285, 2002" to change the zone from Industrial 1 (I-1) to Industrial 5 (I-5). The new zone would change the minimum parcel size from 2.0 hectares to 1.0 hectare to facilitate a two-lot subdivision and increase the parcel coverage from 30% on the first hectare and 5% on remaining hectares to 40% parcel coverage.
