QUESTIONS & ANSWERS

- Q1) Assemble a Value Engineering Team (page 5). Can you provide information about the anticipated "third-party subject matter experts invited by RDN to the workshop"? Specifically, the number of subject matter experts, and their areas of expertise?
- A1) The RDN is considering one or two third-party subject-matter experts to attend the workshop, depending on the composition of the proposed VE Team and the budget. The experts have experience in wastewater treatment processes.

- **Q2)** Assemble a Value Engineering Team (page 5). Roughly how many team members from operation/engineering staff are anticipated to be part of the VE team?
- A2) The RDN has planned for one staff member from each department (two total RDN staff). However, the RDN is open to input from Proponents on the composition of the VE Team.
- Q3) Regarding point 7e ("Three samples of value analysis reports and cost estimates from similar projects and scopes of work. Details can be removed for confidentiality purposes provided overall content and structure can still be understood and evaluated."). Is the RFP requesting copies of the full reports, or would a written summary of the reports in paragraph form suffice?
- **A3)** Full reports are requested, however, appendices can be omitted.
- **Q4)** Regarding point 7e ("Three samples of value analysis reports and cost estimates from similar projects and scopes of work. Details can be removed for confidentiality purposes provided overall content and structure can still be understood and evaluated."). Could we provide the reports' tables of contents and samples from each section to represent the steps usually followed in a VE Study?
- A4) See response to 'Q3' above.
- Q5) Is an in-person workshop mandatory?
- A5) The RDN's preference is for an in-person workshop. However, the RDN will consider a remote workshop if there are reasonable constraints to holding an in-person workshop. In such case, Proponents should describe the constraints to hosting an in-person workshop and provide details of the proposed alternate workshop delivery.
