

PURPOSE OF PROPOSED BYLAW

This application proposes to amend "Regional District of Nanaimo Land Use and Subdivision Bylaw No. 500, 1987" by changing the Subdivision District from 'D' to 'F', reducing the minimum parcel size from 2.0 hectares to 1.0 hectare. If successful, this amendment would make it possible for the applicant to pursue a two-lot subdivision application.
