

ZONING AMENDMENT
APPLICATION NO. PL2022-139
594 Karl's Way, Electoral Area G

PURPOSE OF THE BYLAW

The subject property is currently zoned Residential 1 (RS1) and contains a church. The church was constructed in 1980 and permitted under the zoning bylaw at that time. Subsequently, the zoning bylaw was amended to residential use only and the church now has nonconforming status. The applicant proposes to rezone a portion (0.31 hectares) of the subject property from Residential 1 (RS1) zone, Subdivision District 'Q' to Public 1 (PU1) zone, Subdivision District 'Q' to recognize the existing church. The applicant wishes to maintain a portion (0.0711 hectares) of the subject property as RS1, Subdivision District Q, as an option to subdivide one RS1-zoned lot from the parent parcel at a future date.

HAVE YOUR SAY

All persons who consider their interest in their property to be affected by the proposed bylaw shall be afforded an opportunity to be heard in person or by written submission at the Public Hearing. Written submissions can also be provided in advance of the Public Hearing and must be received at the RDN Administrative office by **4:30 p.m. on Tuesday, June 13, 2023**, to ensure their inclusion in the public record. Written submissions may be submitted by email to *planning@rdn.bc.ca* or by mail or in person to 6300 Hammond Bay Road, Nanaimo, B.C., V9T 6N2.
