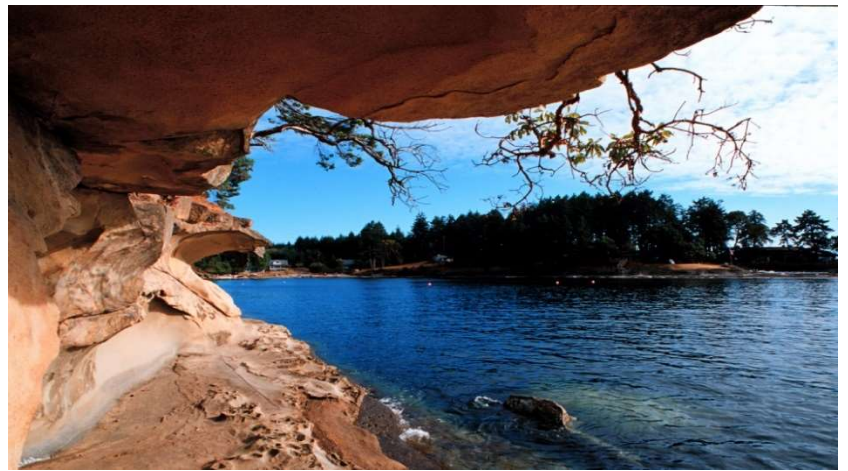

### ABOUT THE ROLE

The Regional District of Nanaimo is seeking a temporary full-time Parks Technician with the Parks Services department.

Reporting to the Parks Operations Coordinator, the Parks Technician contributes to the effective operation of the Regional District's community and regional park system through performing a wide variety of field tasks related to the development and maintenance of the parks system. Tasks include trail construction, and maintenance, installation and maintenance of park structures including bridges, gates, benches; site review and routine park, playground and trail inspections and maintenance; tree care, maintenance, inspections and hazard abatement; and participation in park redevelopment projects.

### QUALIFICATIONS

Qualifications for this position include a diploma specializing in parks maintenance, or a related field, plus two (2) years of job-related experience in park operations, preferably in a municipal or regional government setting or an equivalent combination of training and experience. We are looking for someone with excellent knowledge of methods, procedures, techniques, trends, materials and equipment utilized in the development and maintenance of parks and trails. The successful applicant must hold a current Level 1 First Aid with CPR certification (or be able to obtain) and a valid Class 5 BC driver's license.

### POSITION DETAILS

This is a temporary full-time (40 hours per week) union position for three (3) months, with the possibility of ending early or extension based on operational needs. The (2024) rate of pay is \$38.17 to \$40.18 per hour plus 12.4% in lieu of benefits including vacation and statutory holidays, or the uninterrupted continuation of their benefits package as provided for in the Collective Agreement between the Regional District of Nanaimo and the Canadian Union of Public Employees, Local 401.

**Job Summary**

The Parks Technician contributes to the effective operation of the Regional District's community and regional park system through performing a wide variety of field tasks related to the development and maintenance of the parks system. This position provides support to the Recreation and Parks team in meeting departmental goals and objectives.

---

**Primary Duties and Responsibilities**

- Reviews, adheres to, and supports the adherence to safe work procedures in the workplace and generally promotes a safe work environment.
- Performs a variety of field tasks related to the development and maintenance of parks, including trail construction, and maintenance, installation and maintenance of park structures including bridges, gates, benches; site review and routine park, playground and trail inspections and maintenance; tree care, maintenance, inspections and hazard abatement; and participation in park redevelopment projects.
- Assists with the daily, annual and long-term operational park plans for current and future park needs. Provides input into park infrastructure renewal programs and risk management programs.
- Responds to public and staff concerns regarding park conditions by means of site visits and where necessary undertaking remedial action or advising the Parks Operations Coordinator of best methods to provide solutions.
- Works with a variety of equipment including chainsaws, weed eaters, generators, mowers, power tools and maintains and repairs equipment. Follows WHMIS and WCB work safe guidelines and other safety programs and procedures.
- Carries out, under direction of the Parks Operations Coordinator, the park signage program including sign design, working with contractors and installation and maintenance.
- Assists in the development and implementation of policies and operational procedures related to the management of the Park system, and provides assistance in risk management assessment of park sites.
- Assists with planning, coordinating and delivery of community and regional park services through working with parks staff, contractors and volunteers in the RDN.
- Provides input and communicates with parks staff, community organizations, consultants, and individuals on the development of conceptual plans and detailed designs for park development/redevelopment, park management plans, and park acquisitions.
- Attends community organization meetings and electoral area parks advisory committee meetings to provide information, liaison and support regarding the Park system and its operations.
- Assists with a variety of Parks system administrative tasks including the documentation of risk management programs and park issues.
- Performs other related duties as required.
