On Saturday, October 25, 2025, an assent voting opportunity will be held in Electoral Area F of the Regional District of Nanaimo on the following question:

“Are you in favour of the Regional District of Nanaimo adopting “Electoral Area ‘F’ Community Parks and Halls Local Service Property Purchase Loan Authorization Bylaw No. 1929, 2025”, which will authorize the Regional District of Nanaimo to borrow up to eight hundred and twenty-four thousand dollars (\$824,000), plus interest, repayable over a period of no more than ten (10) years, to finance the purchase of a 3.7 hectare (9.15 acre) property located at 2350 Alberni Highway, Coombs, (known as French Creek School) for use by the Electoral Area ‘F’ Community Parks and Halls Local Service?”

Scrutineers for and against the question must be appointed if applications are received from persons who wish to volunteer for the positions. Only persons entitled to vote as electors in this assent voting opportunity are entitled to act as scrutineers.

If sufficient applications are received, one scrutineer for and one scrutineer against the question will be appointed for each voting place. One scrutineer for the question and one scrutineer against the question will also be appointed to be present at the determination of the official results and, if necessary, at a judicial recount.

Applications to act as a scrutineer will be received by the Chief Election Officer at the Regional District of Nanaimo Administration Office, 6300 Hammond Bay Road, Nanaimo, BC V9T 6N2 or by email at [vote@rdn.bc.ca](mailto:vote@rdn.bc.ca) during the period of **8:30 a.m., Monday, September 22, 2025 to 4:30 p.m., Friday, October 3, 2025.**

Applications will not be accepted after 4:30 p.m. on Thursday, October 23, 2025.

### Important Deadline

As provided in the *Local Government Act*, a mail ballot must be received by the Chief Election Officer before the close of voting (**8:00 p.m.**) on general voting day (**Saturday, October 25, 2025**) in order to be counted for the assent voting (referendum). It is your responsibility to deliver or post the mail ballot in sufficient time for delivery to the Regional District of Nanaimo Administration Office at 6300 Hammond Bay Road, Nanaimo, BC V9T 6N2 by the deadline.
