

Well Water Testing Rebate Pre-approval Application



The Regional District of Nanaimo (RDN) offers 50% rebates (to a maximum of \$350 rebated) for private domestic well water testing to better understand the health of regional groundwater. When the rebate is open, applications are processed on a first come, first served basis. If you are approved, the RDN will issue you an ID number to submit with your well water sample to the lab. Allow up to six weeks for processing. For program details visit www.rdn.bc.ca/well-water-testing.
