Action Groups/Standing Report:

Poverty Reduction Strategy – No report – Courtney is away.

Child Wellness Group (CWG) – The First 2000 Days Forum is scheduled to take place October 29th and November 5th from 9am to 1pm. The meeting will be held over Zoom. The Save The Date invitation will be out this week. All CoP members are invited to attend the event. We are looking for volunteers to help with the scribing for the breakout groups. Gerry will be delivering the opening and welcoming remarks on behalf of OHWN.

Seniors Planning Table (SPT) – The group met in person at the S.O.S. Marlys joined over Zoom, it was extremely hard to hear. Susanna asked Jane to follow up on the action item to invite members from local seniors' centres to join the SPT. The group is still trying to find their way forward considering COVID-19, as the planned actions to meet with seniors at local events is now no longer possible. The SPT needs to recruit new members. They are planning to go to the more remote and rural areas and have information tables to share and get information from social isolated seniors.

CRN Island Wide Regional Gathering has been deferred to late January / February 2021 Topic: Decolonizing community networks.

United Way's Healthy Aging Core – Jane O is working on the upcoming regional event. Jane O will share the link to the site with the CoP.

Perfect Storm (PSG) – Over the next four years, residents of Oceanside will benefit from more than 23 full-time equivalent health providers who will provide better access to primary care. This includes nurse practitioners, family physicians and allied health professionals such as registered nurses, social workers, occupational therapists, and a clinical pharmacist. The Oceanside primary care network will see community partners working together to ensure thousands of people have access to comprehensive, coordinated, and team-based primary care services for all of their day-to-day healthcare needs in the region. As a result of the announcement, the proposal for the Feasibility Study has been put on pause.

Coordinator Updates:
