The RDN is offering rebates of up to \$750 to help residents install cistern(s) with 4,546 litres (1,000 imperial gallons) of rainwater storage or more. Rebates are available until December 15, 2022 or until funds are exhausted. Apply for pre-approval and "reserve" funds for eligible work for up to 90 days. If you qualify for the rebate, an approval letter will be sent to you.
