**A BYLAW TO SET VARIOUS FEES AND CHARGES
WITHIN THE REGIONAL DISTRICT OF NANAIMO**

WHEREAS Sections 63, 235 and 244 of the *Municipal Act* provide for the establishment of fees and charges for the provision of information;

AND WHEREAS it is deemed desirable to establish rates for the provision of a variety of miscellaneous services;

NOW THEREFORE, the Board of the Regional District of Nanaimo in open meeting assembled, enacts as follows:

1. The various fees and charges as set out in Schedules 'A', 'B', and 'C', attached hereto and forming part of this bylaw are hereby imposed.
2. This bylaw may be cited as "Regional District of Nanaimo Fees and Charges Bylaw No. 944, 1994".
