SUBJECT: Capital Projects List

The purpose of this memo is to provide a convenient reference list of the majority of the Board's capital plan. This is a public document that will be posted and shared on the RDN website. Table 1 provides information about which services have the majority of Capital throughout the 2025 – 2029 Amended Financial Plan. Specifically, there are 8 services plus our Fire Services that have \$514.0 million of the \$553.2 million or 93% of the Capital in the 2025 – 2029 Amended Financial Plan. 98% of the New Debt and New Debt Servicing has also been identified within these services.
