Action Groups/Standing Reports - Highlights & Questions

- At the CWAG meeting on October 16th Gerry raised the concern of the impacts of lack of access to doctors and nurse practitioners on children coming into the community see Letter from PQB news. Joanna shared that the CIDFP has brought three more family practitioners to the community and the health link BC wait list is coming down. A provisional Nurse Practitioner (NP) added to Flower Stone, but she cannot put people on her panel until her results come in at the end of December. There are four NPs in Oceanside and filled one position with a provisional NP and helping Snaw-Naw-As hire a fulltime NP there as well. Trying to get Oceanside Health Centre designated as an Emergency Department.
- Jane O BC CRN updates this is for community organizations and agencies we are restarting a series including and affirming LGBTGQ folks in all our health services
- Elaine Open House Forward House Sunday 1 to 5 in Parksville, \$10K collected from grocery stores for recovery programs
- Jane V shared the update from Jamai Schile re: <u>Social Needs Assessment Strategy</u>

Long Range Planning (LRP) Update

- First planned activity is membership survey and report
- Planned end date now for LRP is end of February

Gerry shared that the OHWN coordinator contract and job description are overwhelming. Jane hopes to focus more on recruitment of key partners and stewarding work to get the community members to the table in the new year.

- Province is looking for 25% reduction in poverty by 2024 and a 50% reduction in child poverty they say they have met that goal, but this may not be true due to Covid 19.
- Adam Walker is looking for change to the gig economy and he is leading a commission to the employment standards act that folks may be interested in
