What is Household Hazardous Waste?

Household hazardous waste (HHW) is leftover household products that are flammable, corrosive, reactive or poisonous. It also includes some liquid products that should not be disposed of in the garbage or down the drain.

Important Notice!

The RDN does **NOT** accept materials included in B.C.'s **Provincial HHW Recycling Programs.**

Provincial HHW Recycling Programs accept only select recyclable materials, such as:

- Paints and stains*
- Used oil and antifreeze*
- Flammable liquids and gasoline*
- Batteries*
- and gasoline M
 - Medications*
- Pesticides*

*Exclusions and drop-off conditions exist

These materials can be returned to participating recycling depots without an appointment and at no additional charge. Find out where at rdn.bc.ca/what-goes-where. See the back of this pamphlet to learn more about these programs.

Reduce Your HHW Output

Only buy as much as you need. **Consider donating** unused products to non-profit organizations or offer them to a friend or neighbour.

B.C.'s Recycling Programs

B.C. requires that producers of certain product types must collect and recycle their waste products and packaging. This approach to recycling is called **Extended Producer Responsibility** (EPR). Similar products, like paints and stains, are often managed by a single EPR program.

EPR programs are funded by environmental handling fees that are added to consumer purchases of program products.

Scheduling an HHW Drop-Off

To drop off your HHW at an RDN solid waste facility, you are first required to register your HHW. This step will:

- Ensure prohibited materials are directed to the proper disposal locations
- Improve safety for residents and RDN staff
- Reduce disposal fees and operational costs

Schedule a drop-off appointment by selecting from the available time slots.



RDN staff will review your registration request and send you a **confirmation email**. Read this email carefully as it contains important information to help keep you and RDN staff safe!
